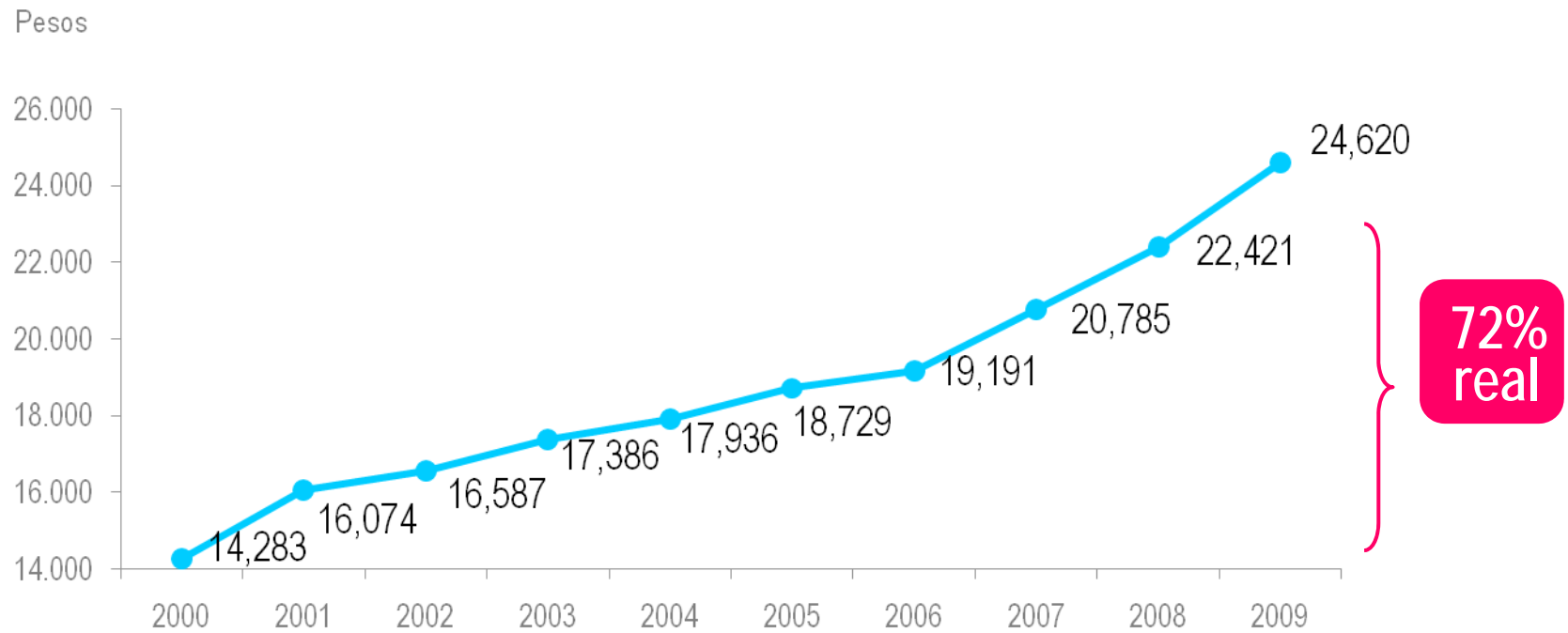

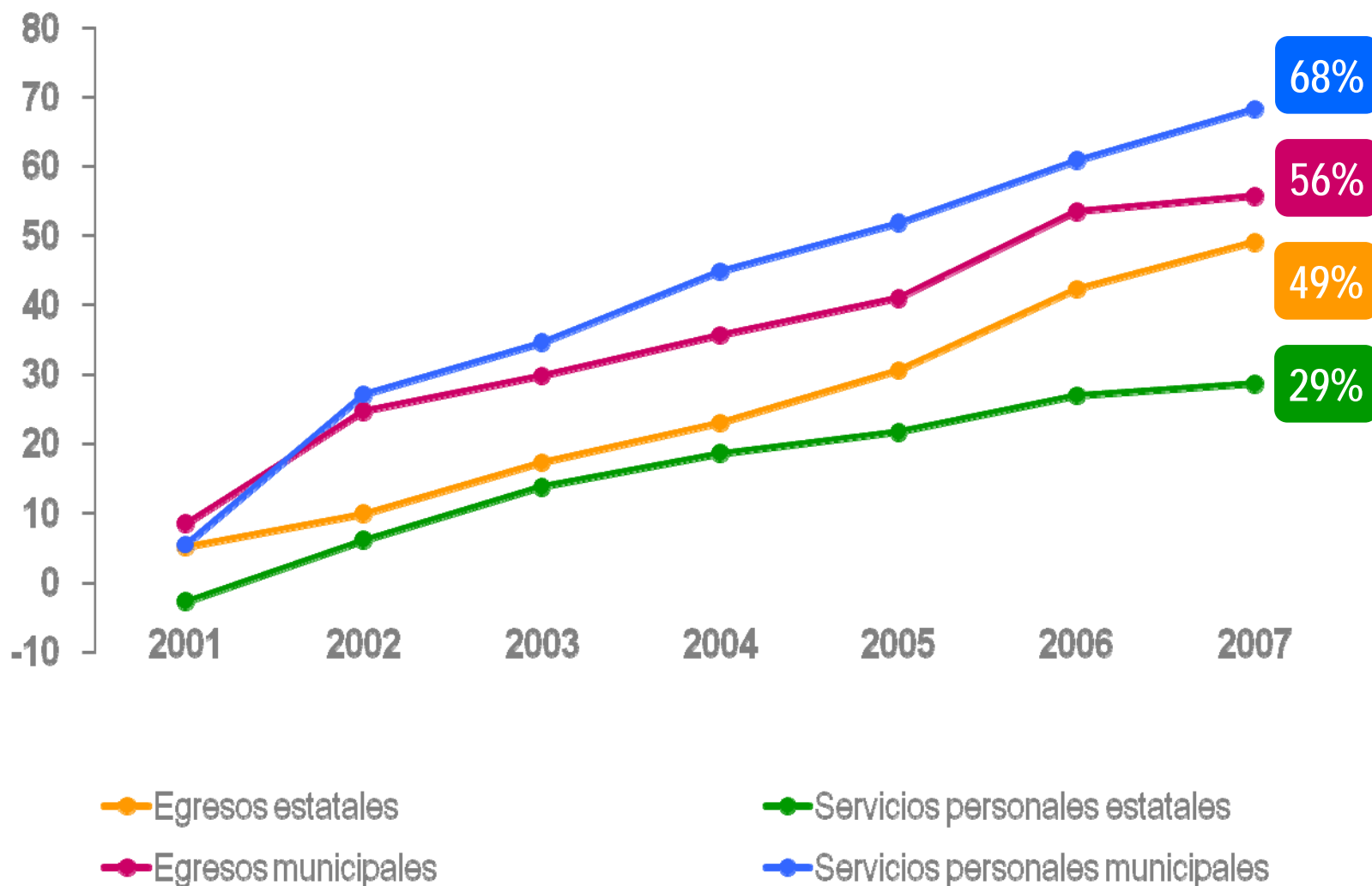

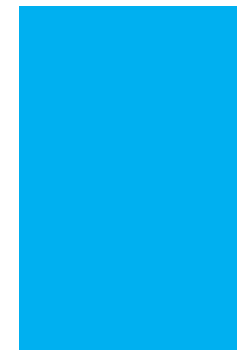

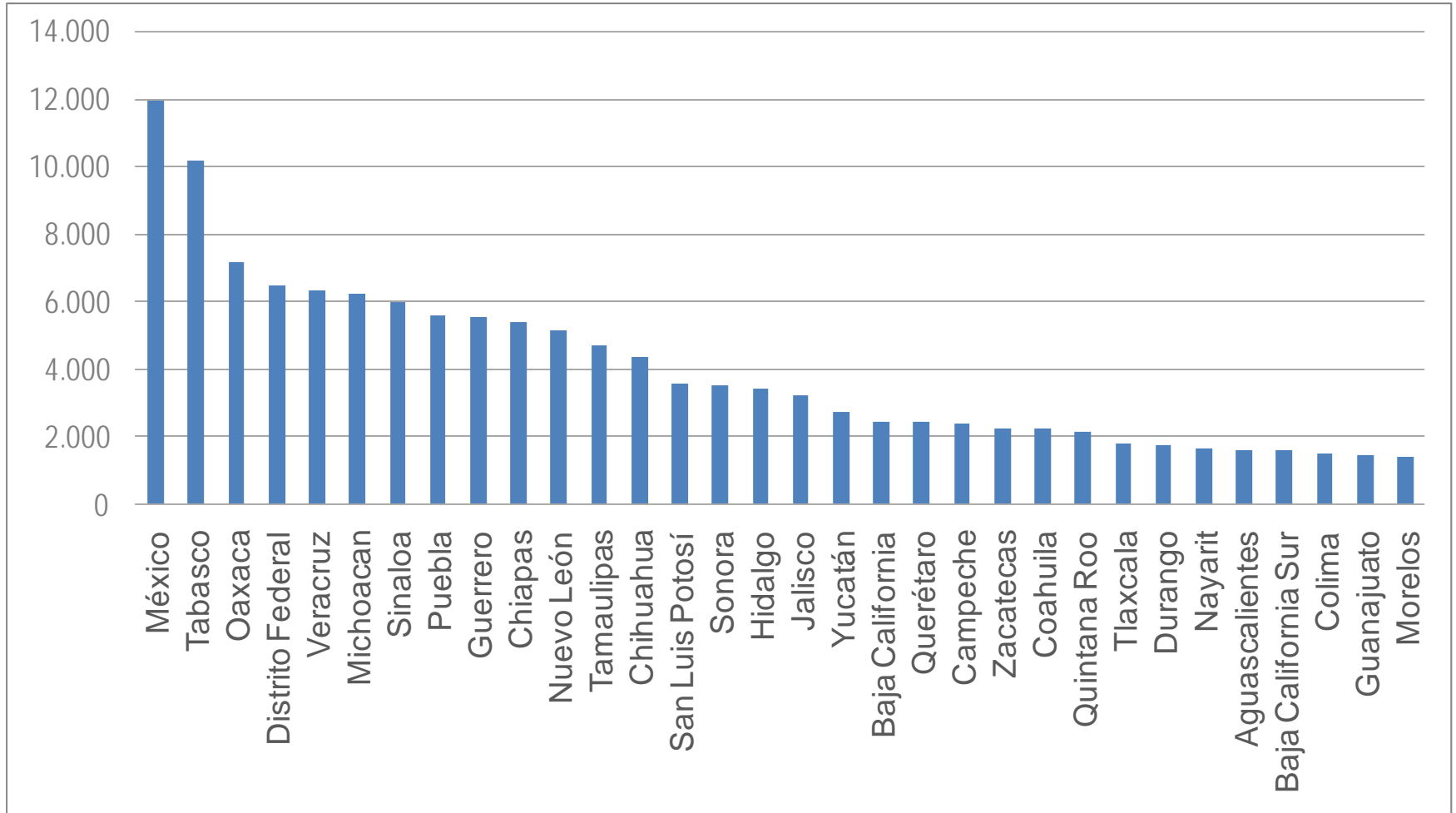
Gasto Presupuestado vs. Ejercido 2006

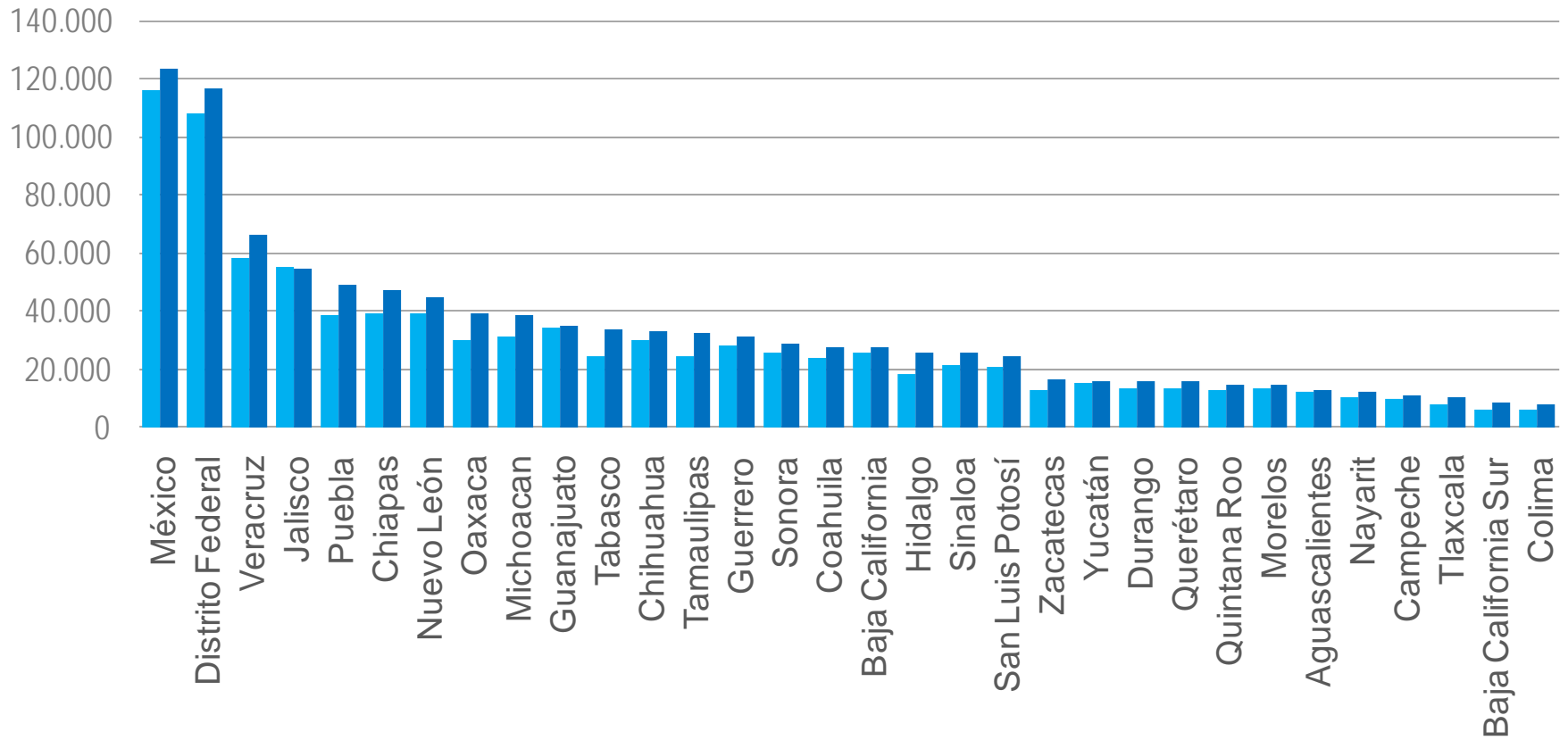

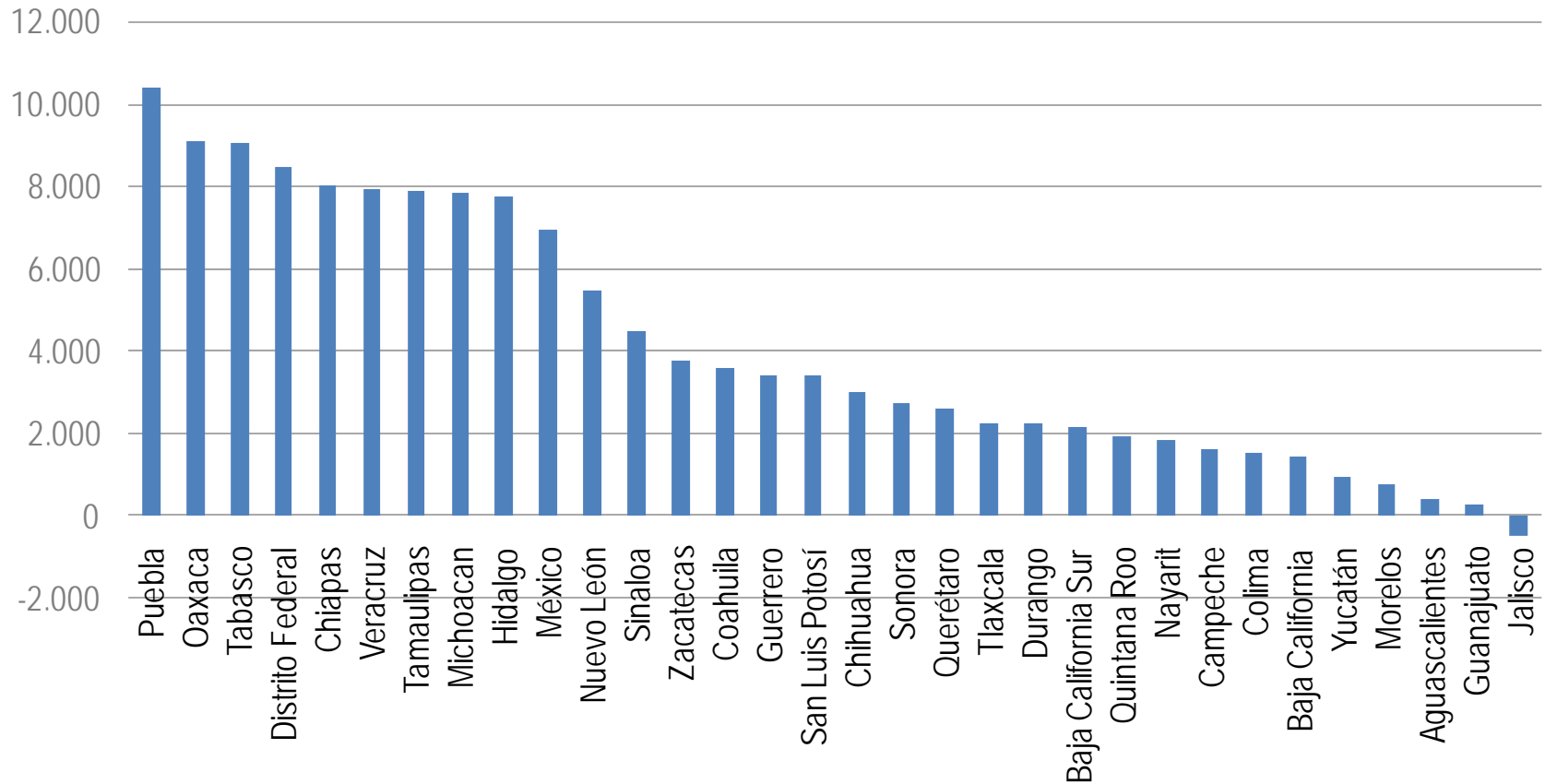

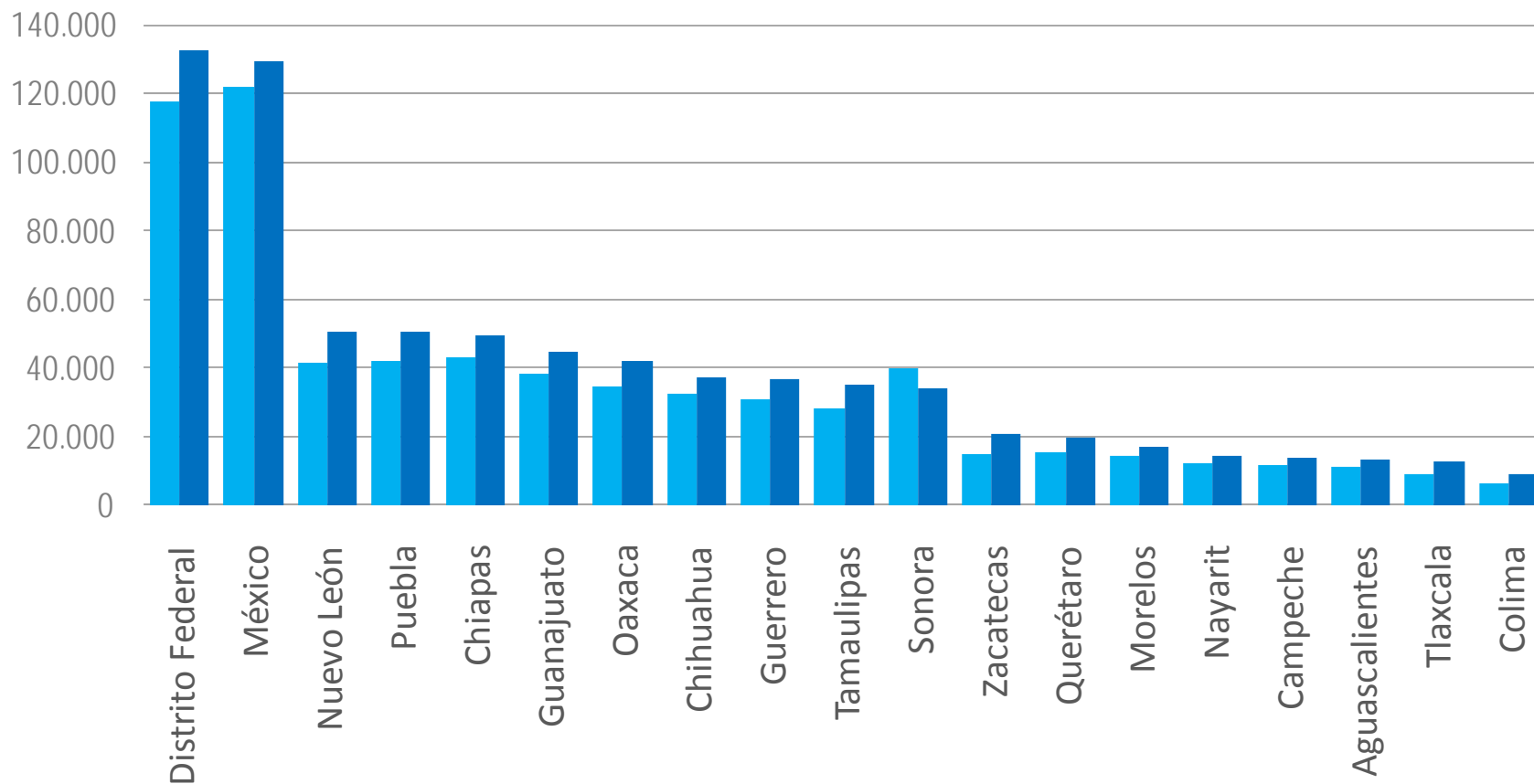

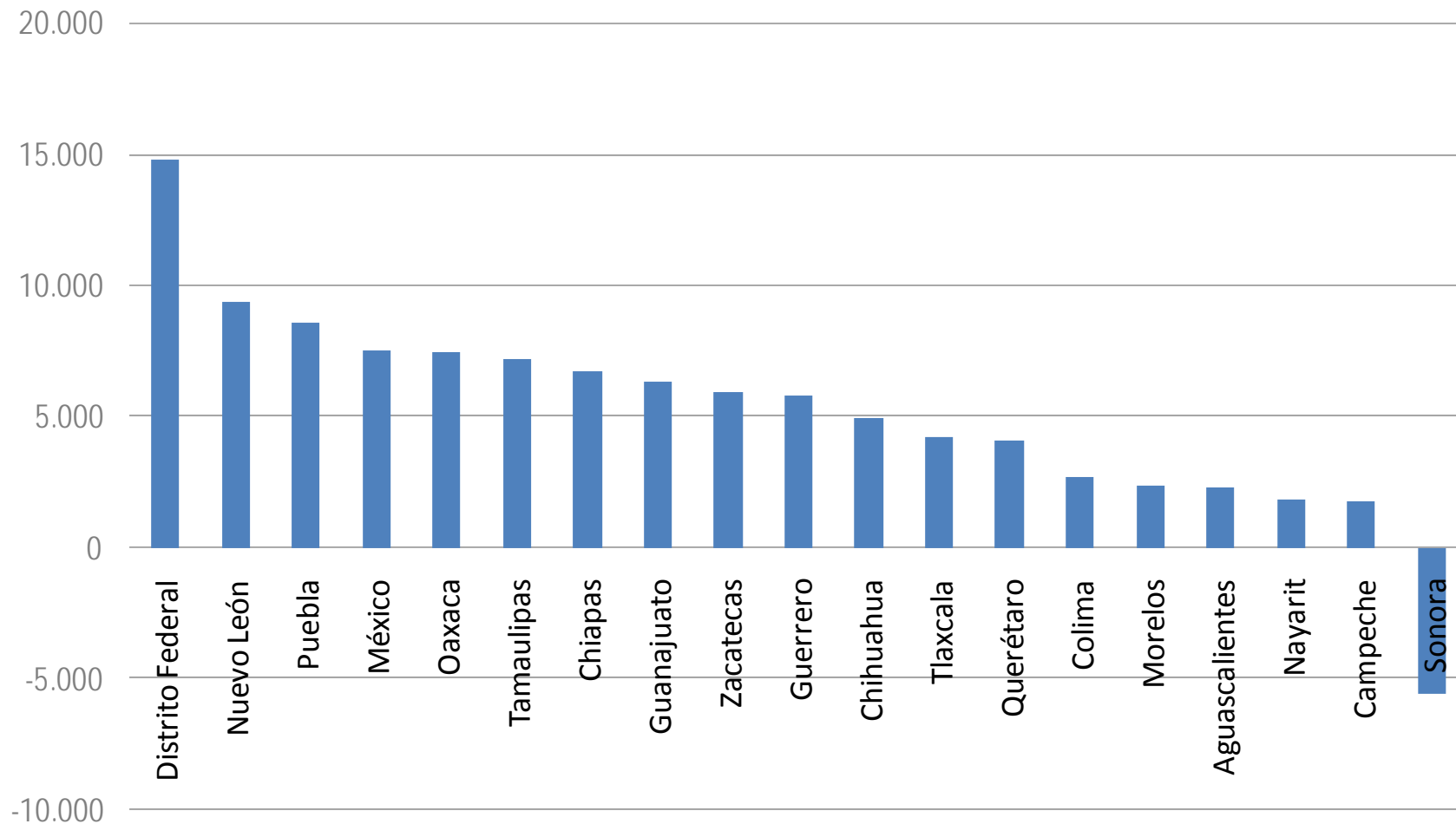

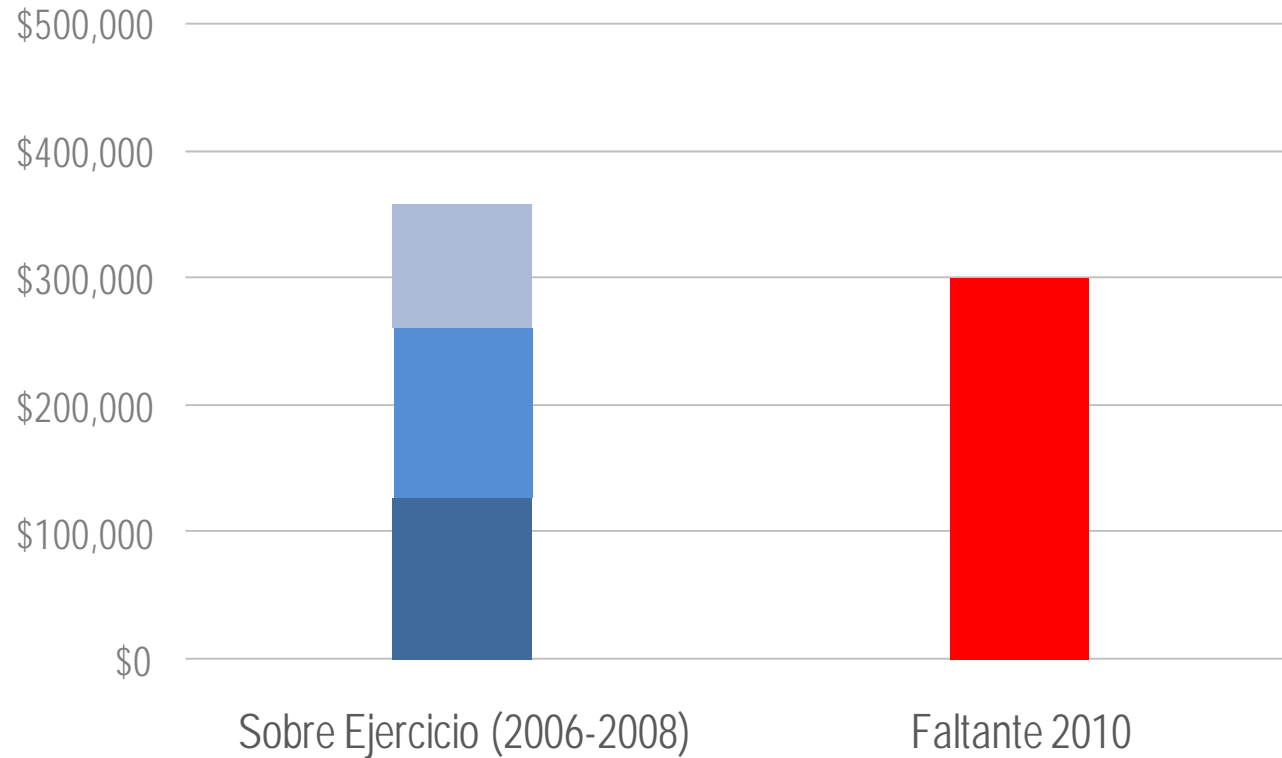
